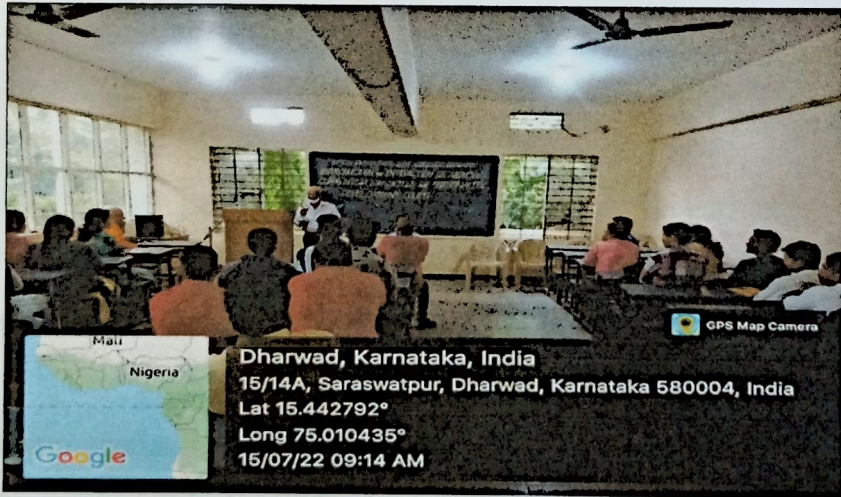

Summary Report on Add-on Course

As per the decision taken by college Management and Add-on course committee the following Add-on Courses were conducted successfully for the Academic year 2021-22.

Each add-on programme was conducted for 30 hours. The curriculum content is separately framed for each course. The students of different semester are permitted to enroll add on courses of their choice. For the academic year 2021-22, there were 3 add-on courses. During the odd semester Add-on course on Yoga was conducted and other 02 add-on courses were conducted during even semester. Certificate of completion is given to students only those who attend 90% of classes engaged.
