## **STUDENT MENTORSHIP POLICY**

To motivate and promote average and below average students to cope up the existing course curriculum and also facilitating the advanced students to nurture their learning abilities, skills, potentialities and also enabling them to share their knowledge with fellow mates, college has framed a simple guidelines on Student Mentorship Mechanism. This mechanism helped student lawyers to get connected each other and enabled them to actively involved in curricular, cocurricular and extra curricular activities. Each student mentor is allotted a group of student mentees. Every student mentor is supported and guided by faculty members in handling the mentee and helping every mentee to cope up the course curriculum with utmost effort. The allocated mentee to the respective student mentor is instructed them to meet and get the academic help from time to time. Mentee also instructed to confine their problems only with regard to academic challenges, internship only. Student Mentor must be available to the mentee as per the prescribed

time slot. They are also instructed to keep track of problems identified and resolved accordingly and the same is to be reported to the concerned faculty members once in a month.

### **PROCEDURE ADOPTED TO SELECT STUDENT MENTORS**

Following mechanism is adopted in the college to identify student mentors

- Student mentor is restricted to 10 only, those who are in the final year.
- Student mentor is chosen based on their academic performance.
- The students are assigned mentorship on the basis of their excellence in academics and good performance at examinations. This will help the mentees to take help from their peer mentors in the matters relating to academics and examinations
- Students who have good communication skills are assigned mentorship so that student mentees can easily understand the guidance and suggestions given by the mentors
- Students mentors are selected on the basis of their ambition to pursue their future profession so that they can influence the other mentees and guide them accordingly
- The mentorship is allotted to the students who are willing and eager to give honest feedback, invest their time and show empathy to fellow mentees.

- Lastly, the mentorship is assigned on the basis of mentors friendly attitude towards their fellow friends so that student mentees can freely share their grievances with the mentors.
