Any additions or amendments to the provisions of this MOU can be made as per mutual agreement between the parties.



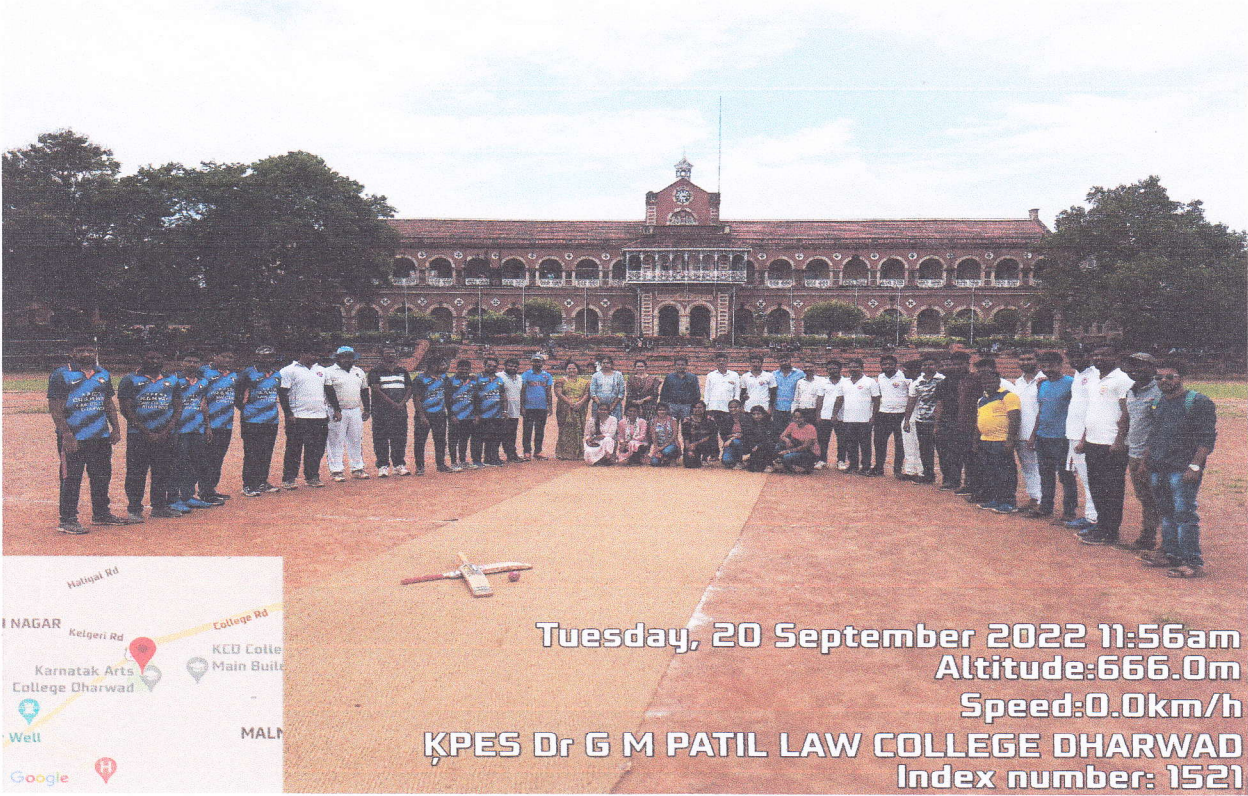


Photo 1: Our College Students Cricket Teams present in final cricket match in the Karnataka College Dharwad ground under MOU.

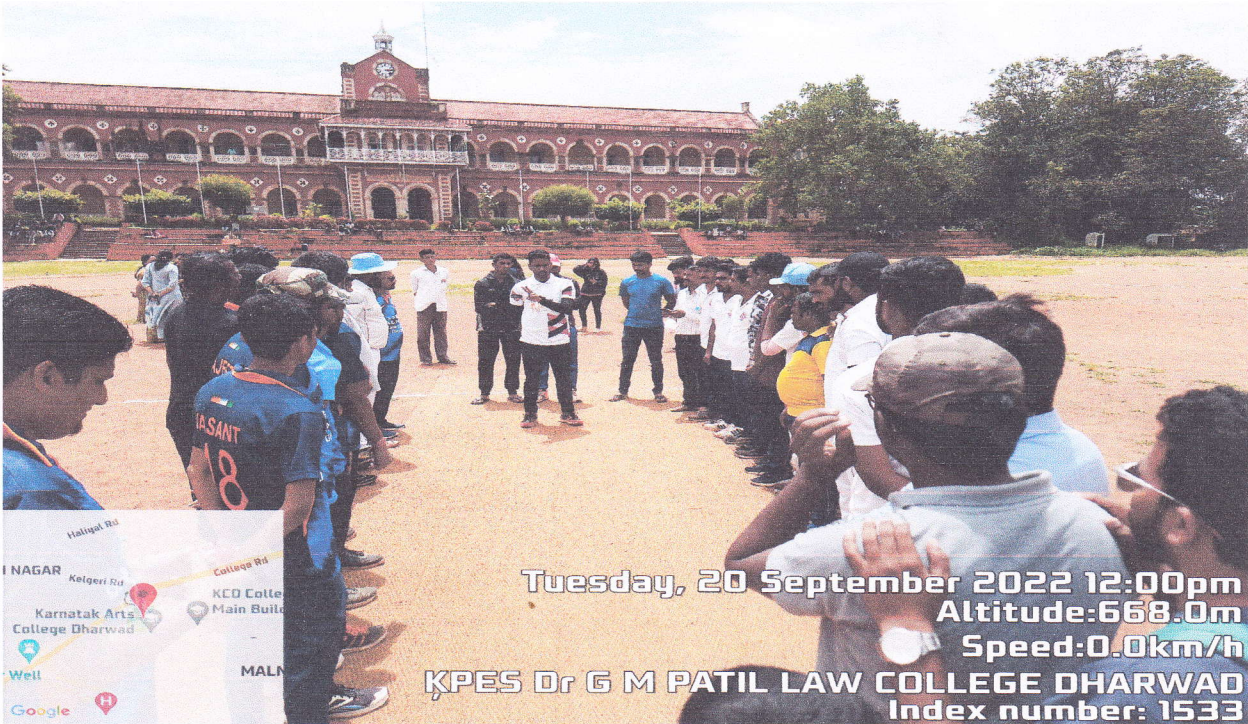


Photo 2: Referee explaining the rules of Cricket Tournament before Starting the match

Any additions or amendments to the terms of this MOU can be made subject to the mutual agreement between both the parties.


