ANTI RAGGING POLICY

In view of the directions of the Hon'ble Supreme Court, and in consideration of the rules framed by the Central Government and the UGC, to prohibit, prevent and eliminate ragging of all students, K.P.E.S's Dr. G. M. Patil Law College, Dharwad has adopted Anti- Ragging Policy.

Objectives of the Policy –

To prohibit, prevent and eliminate any conduct by the students which constitute ragging. Amongst others following are the main objects of the committee

1. To keep continuous watch and vigil over ragging so as to prevent it from happening.
2. To strictly deal with the complaints of ragging brought before the cell.
3. To conduct awareness program on the menace of ragging, its impact, consequences, and redressal mechanism available.

4. To create an ambiance of discipline that no act of ragging shall be tolerated and any act of ragging shall not go unnoticed and unpunished.


Ragging includes, any conduct whether by words spoken or written or by an act which has the effect of harassing, teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or raise fear or apprehension thereof in any students or students or asking any student or students to do any act or perform something which such student or students will not do in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of any student or student.

Anti-ragging Committee –

As per the guidelines of UGC, an Anti-ragging Committee is constituted in the college to provide a healthy and congenial atmosphere to the students of the Institute. The committee is responsible for –

- Implementation of the policy
- To prepare short term and long term action plan.
- To investigate and make inquiry into the complaints related to ragging and take appropriate actions as per law.

The committee has helpline number and the complaints can be made in writing to the committee by the victim. The committee shall make further investigations. Any frivolous

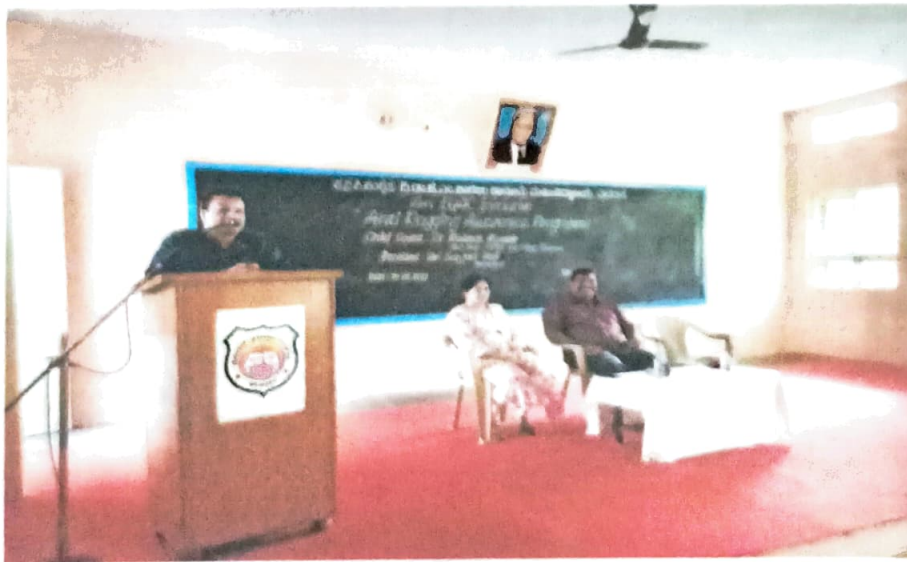
