### Grievance Redressal Procedure

The students have to place their grievances in the suggestions box/complaint box placed outside the library. The grievances can be addressed either to the Principal or the Co-Ordinator of the Cell. The Co-ordinator in turn intimates the matter to the committee for necessary action. The Grievance Redressal Committee shall ensure disposal of every complaint or suggestions as early as possible, and not later than a month of receipt of the grievance. On the conclusion of proceedings, the Committee shall pass such order, as may be deemed fit to redress the grievance and provide relief as may be desirable to the affected party at issue. In case of false or frivolous complaint, the Committee may take appropriate action against the complainant.


