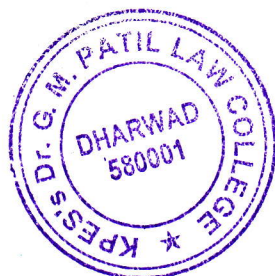

- All members must participate in sports uniform /attire only.
- Matches will be played on a knock-out basis.
- Yonex Plastic Shuttle will be used to conduct tournament, which has to be purchased from the organisers
- Food and accommodation will be provided to the out of station teams on prior request.
- Confirmation of your participation and accommodation requests must be made on or before August 5th, 2022, to allow us time to make the necessary arrangements.
- The decisions of the tournament committee shall be final in all matters pertaining to the tournament.
- Team Managers will be held responsible for indiscipline of their students.

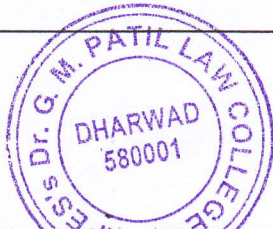
