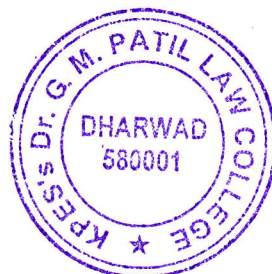

  - Women- Minimum-4 and Maximum-6 (Distance 10 kms)
6. All participants should compulsorily bring Physical fitness certificate from qualified doctor (copy attached)
7. Teams are requested to report on 13<sup>th</sup> July 2022. Route will be shown at 05.00 pm.
8. The competitions shall be conducted according to KSLU guidelines.
9. Confirmation of your participation on or before 09-07-2022 is mandatory (through Email: [hurakadliajjalawcollege@gmail.com](mailto:hurakadliajjalawcollege@gmail.com) However the duly filled in forms can be submitted before the commencement of the event.
10. Unfurnished accommodation will be provided to the out-station teams on prior request.
11. The decision of the organizing committee shall be final in all matters pertaining to the championship.

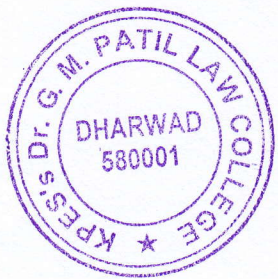
