



Photo 2: Shri. Dawalsab M. Thasildhar 3rd Year LL.B Student receiving 1st prize in Elocution competition




Photo 2: Deep thinking by the head of suppressed class to maintain the family




Photo 4: Climax of exploitation by the village leader
