2. The Paper Setters should prepare **two sets** of Question Papers both in **English and Kannada version (wherever applicable)**. The name of the University should not be mentioned in the manuscript or on the cover containing the manuscripts.
3. The invited paper setters are asked to attend the Scrutiny meeting along with question papers. Only scrutiny of Question papers will be taken-up in the meeting.
4. The Paper Setters to ensure that the **UUCMS Subject Code** is mentioned on the sealed envelope before submitting the same to the Question Paper Branch.

The scrutiny of the Question Paper shall be completed within a day or two. The last date for submission of Manuscripts to QP Branch is **10.04.2024**.
