



There were no appropriate health care services provided, for instance, there was lack of oxygen cylinders and he was made to get it from outside along with the negligence on the part of the nurse to take care of his mother in his absence. The patient along with the complainant had undergone a lot of hassles during her treatment in the said hospital. Thus Mr. Suraj Hegde wants to file under deficiency of service as per *Consumer Protection Act, 2019*.

**DRAFT A CONSUMER COMPLAINT ALONG WITH AFFIDAVIT
AND WRITTEN OBJECTIONS**

Mr. Sakshat Singh purchased laptop from popular dealer of the city "Quality Rider" by paying Rs. 35,000/- (Rupees thirty five thousand only) and gifted it to his daughter Ms. Kajal. Though seller had given two years warranty against the manufacturing defects, within six months of purchase the various defects were found in laptop and the same was communicated by Ms. Kajal to dealer and manufacturer, but no response was received from their side. Finally the device stopped working completely. Ms. Kajal sent legal notice, which went unanswered. Now Ms. Kajal wants to file consumer complaint against the dealer and manufacturer claiming compensation of Rs. 2,25,000/- (Rs Two lakhs twenty five thousand).
