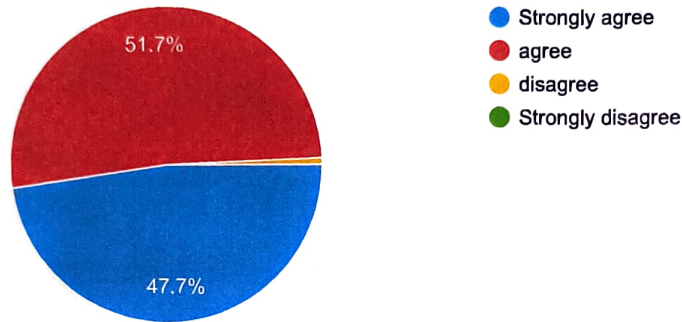

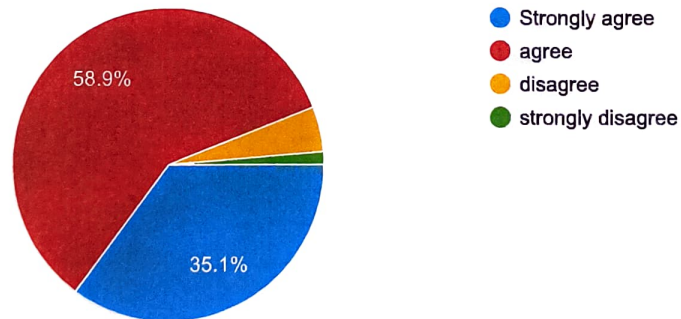

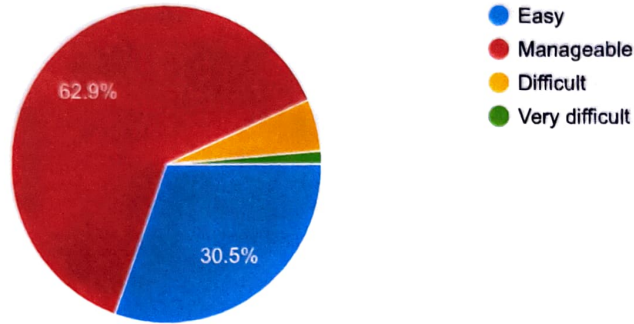

3. Was the syllabus easy or difficult to understand?



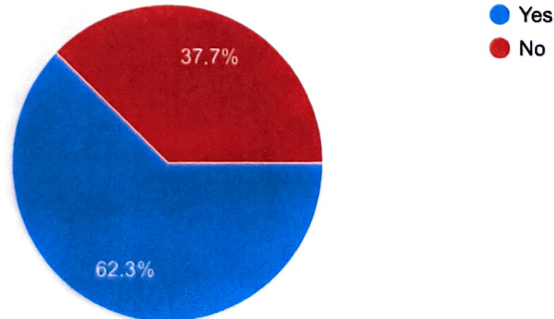

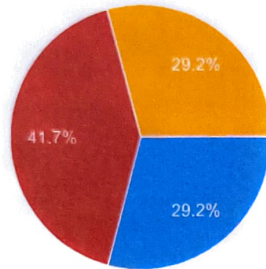
