

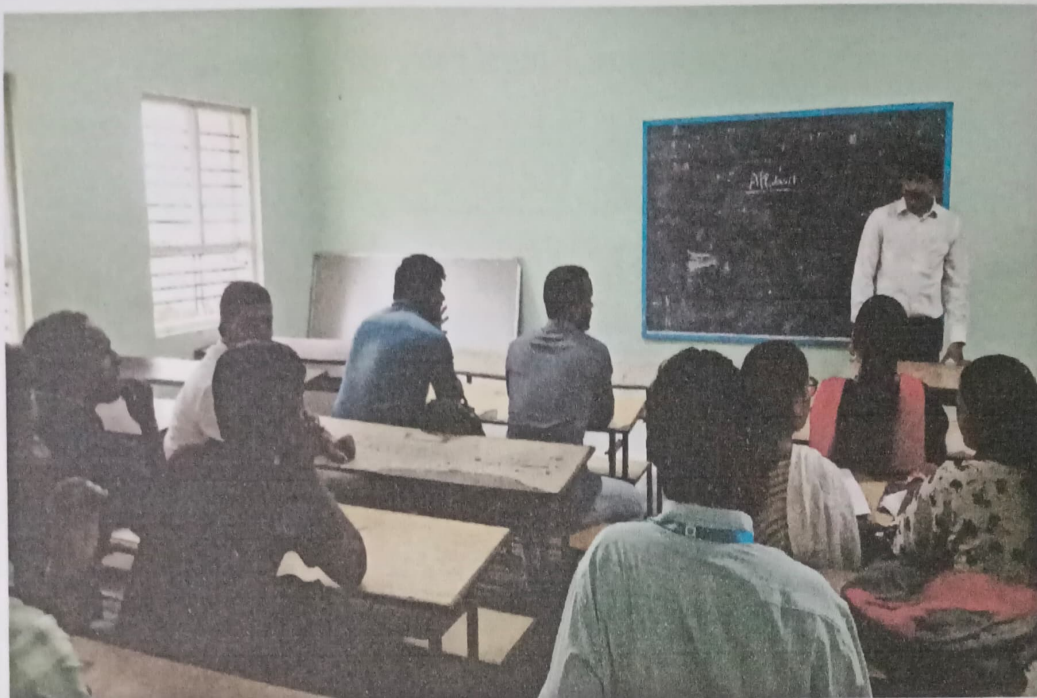



Photo 1: Shri Suresh S. S. engaging Legal Language Class

Summary Report on Add-on Course

As per the decision taken by college Management and Add-on course committee the following Add-on Courses were conducted successfully for the Academic year 2018-19.

Each add-on programme was conducted for 30 hours. The curriculum content is separately framed for each course. The students of different semester are permitted to enrol add on courses of their choice. For the academic year 2018-19 there were 5 add-on courses. During the odd semester Communication Skills and Personality Development and Basic Computer courses were conducted and in the even semester Yoga course, Legal language and Translation add-on courses were conducted. The Translation Course was only for final year students. Certificate of completion is given to students only those who attend 90% of classes engaged. Majority of the student participants expressed their gratitude to the Institution for having conducted these value based courses without imposing any fees on them. The overall content of respective courses enabled students to compete different competitive examinations and students who got Sanad, started practicing the profession under the supervision of senior Advocates. Of the overall percentage of the students participation in different add on courses is more than 80% as against the ceiling limit of intake.
