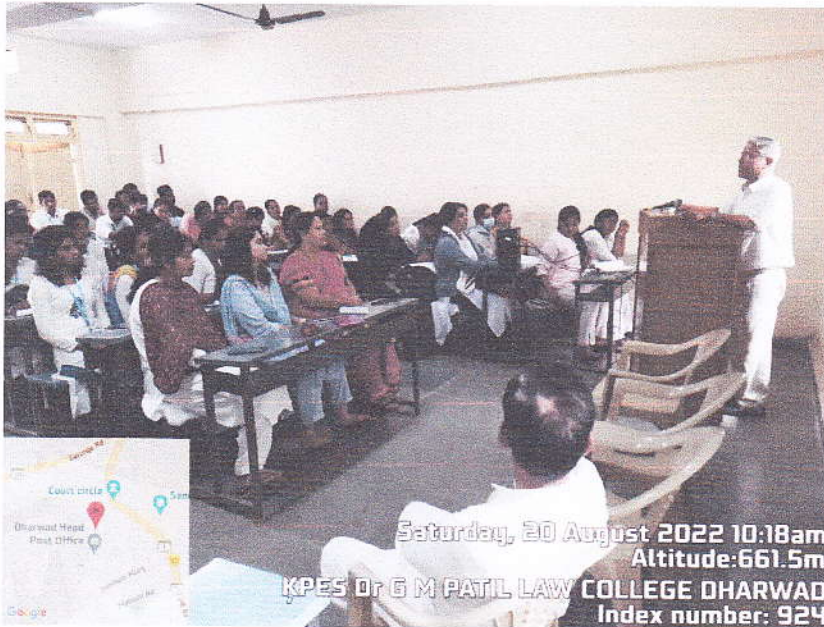


Photo 1: Shri. Basavaprabhu Hoskeri, Advocate engaging special lecture on preparation and presentation of moot court problem

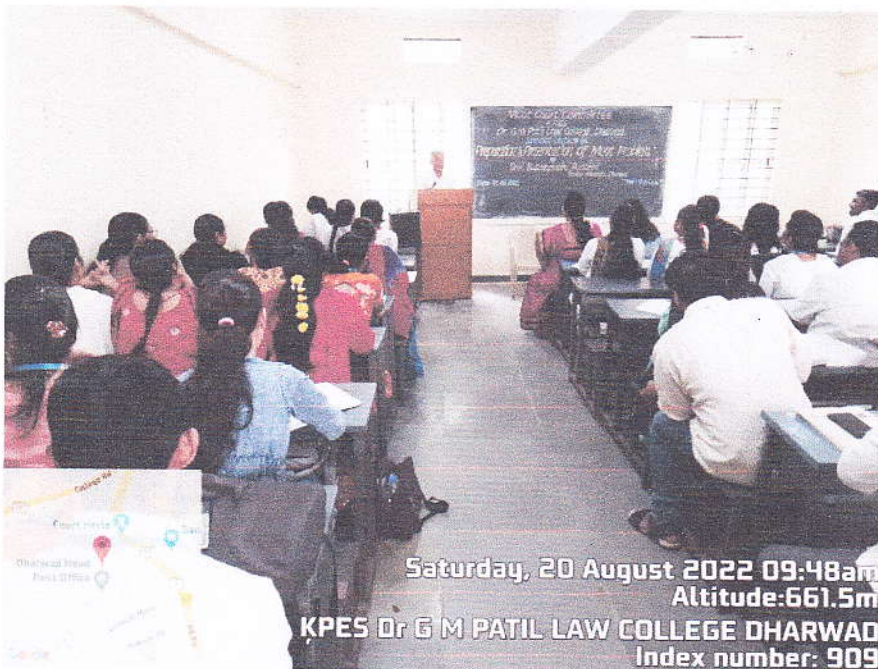

Basavaprabhu Hoskeri, Alumni, Senior Advocate, Dharwad. Sir elaborately told the students regarding the key points to be taken into consideration while preparing memorials for moot problem, and explained in brief the difference between a pleading in original suit and a moot court problem. He also highlighted the skills required for presentation of the case before the judge and spoke on court manners a student should follow in the court room. He then said before writing memorials systematic research is required. More than 70 students participated.
