


Photo 1: Shri. S. G. Patil welcoming the gathering.




Photo 2: Chief Guest Shri. Rajesh Navalgimath addressing the students regarding advocacy skills




Photo 4 : Smt. Mahadevi Hutagi, Proposing Vote of thanks
