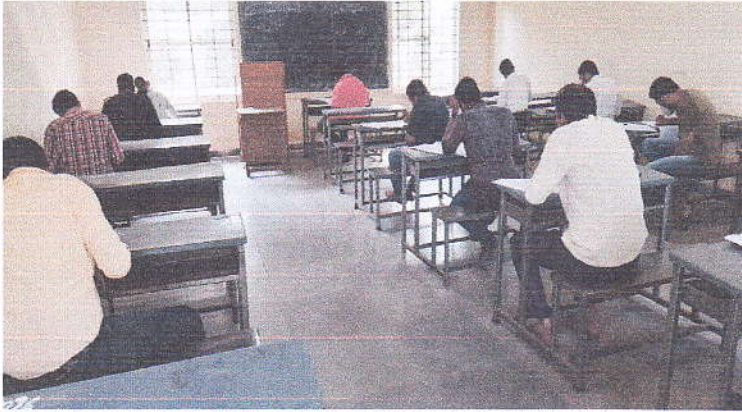


Photo 1: Students practicing drafting in the class
