

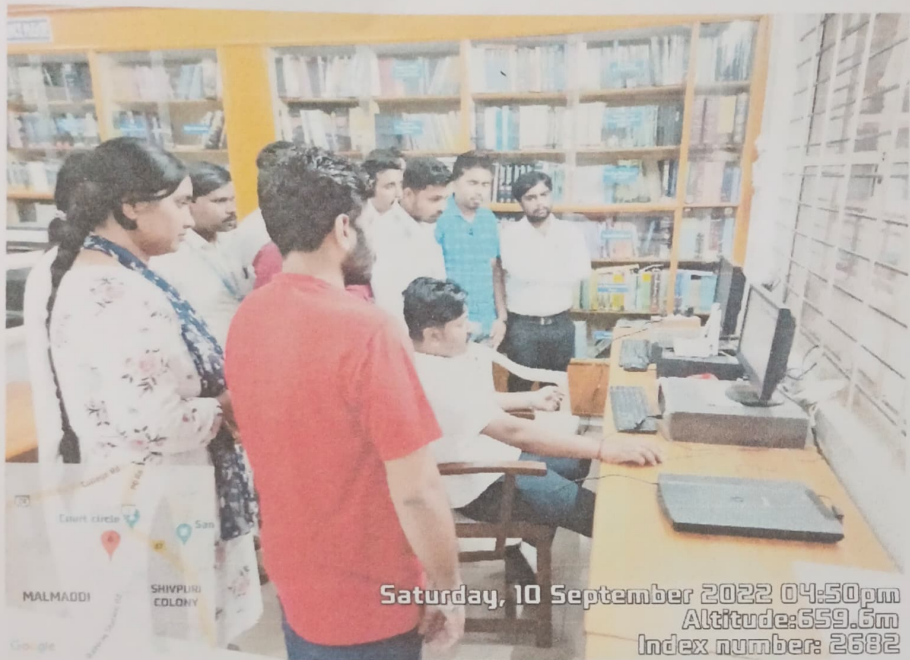


Photo 1: Shri Manjunath G. A. giving training on use of Manupatra

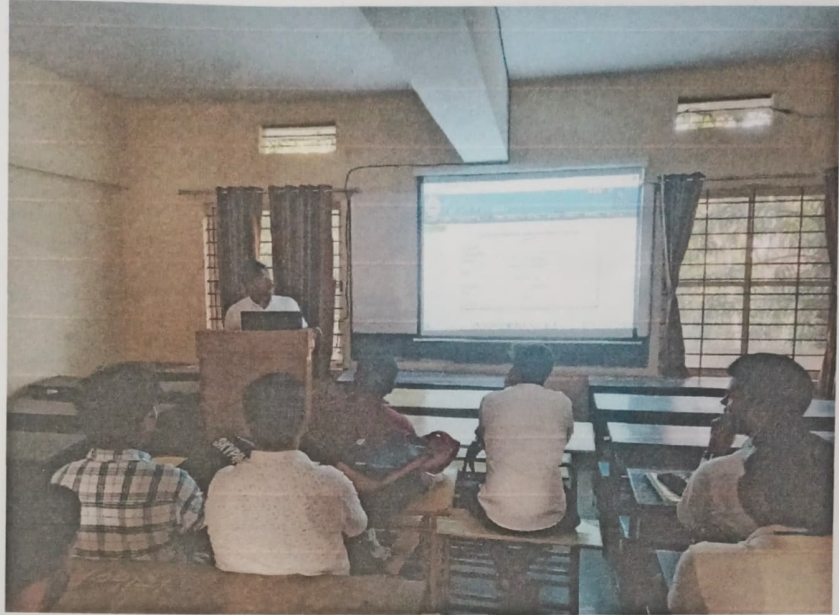



