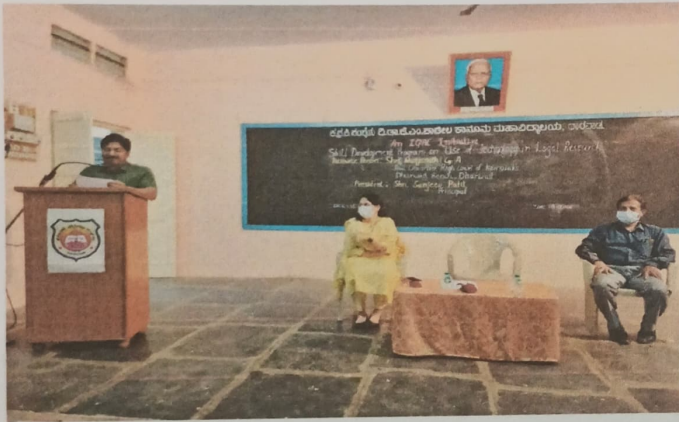




Photo 5: Students and teachers listening to the lecture
