**Instruction to participating teams :**


1. All the Colleges affiliated to KSLU Hubballi are eligible to participate in this Tournament.

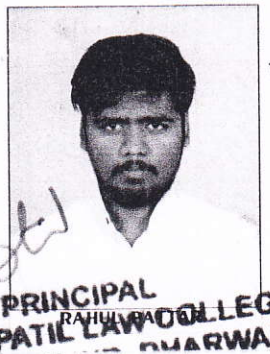

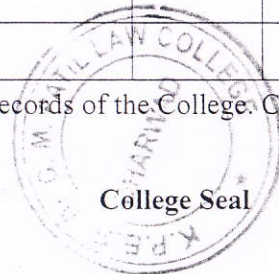

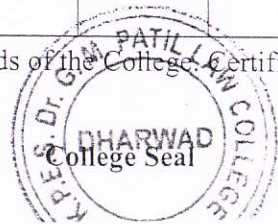
