- 6. The Competition shall be conducted according to the KSLU Guidelines.
- 7. The decision of the Tournament Committee shall be final and binding on all the teams in any matter about the tournament.
- 8. The team members should bring College Recent Identity Cards 2021-22.
- 9. Please confirm your participation by sending an ENTRY FORM on or before 18th July 2022 to enable us to make necessary arrangements and also send a soft copy of the ENTRY FORM to this E-mail Id scl.sports@soundaryainstitutions.in with the signature from the Team Manager and the Principal of your Institution.

NORMS OF THE TOURNAMENT

- 1. The Team Manager's meet is scheduled for 25th July 2022, at 6:00 p.m. in the Ocarina Conference Hall, Soundarya law College Campus, Bengaluru 560073.
- 2. The inauguration of the tournament is scheduled for 25th July 2022 at 7.00 pm.
- 3. All the managers are requested to attend the meeting along with 2 sets of eligibility Proforma signed by the Principal and the Physical Education director.
- 4. The timings of the matches are between 7:00 A.M. and 6:00 P.M. The entire tournament fixture will be informed to the Team Managers on 19th July 2022.
- 5. The matches are played on a knockout basis. The teams are expected to report in **White uniforms.**
- 6. Organisers will provide **Cricket Leather Ball SF Yorker** for which the team has to pay Rs.600/-.
- 7. The teams must report at least 30 minutes before their match, otherwise, the opponent team will be awarded Walkover as per Tournament Norms.
- 8. Each match is played for 20 overs per innings. (It may be reduced depending upon prevailing weather conditions).
- 9. The organizing committee reserves the right to make changes in the tournament program as and when required in consultation with umpires. However, the prior information will be given to the Team Managers for effective execution.
- 10. The decision of the officials is final. In case of any protest, it will be decided by the jury on an appeal within 30 minutes of the match along with the protest fee of **Rupees 5,000/-.**
- 11. After the team registration, if the team is not reported for the tournament a fine of Rs. 5,000/- will be imposed on the team.
- 12. Players have to produce the ID cards whenever asked by the Organizers and Umpires.

- 13. Team Managers are solely responsible for maintaining the discipline of each player throughout the tournament including places of accommodation and traveling.
- 14. The teams are provided an unfurnished accommodation 24 hours before the commencement of matches and the teams have to vacate within 12 hours after losing their match in the tournament. The teams arriving early and vacating late shall make their arrangements.
- 15. The **Second dose of Covid-19 is mandatory for all the Players**, Team Managers, and Coaches and the same has to be certified by the Principal. If any player is found symptomatic, it is requested to avoid entering the tournament for the betterment of all.
- 16. Scoring will be done through 'Cricheores'. For this purpose, the team should submit the duly filled players Performa in MS Excel Form.
