5. The team members should bring recent college identity card (valid through 2021-22), or a KSLU examination hall ticket with fee receipt of the current year.

- 7. In Women selection the team should consists of minimum 2 players and maximum 3 players. The playing order is as shown below:
 - First Singles
 - First Doubles
 - Reverse Singles
- 8. All members must participate in sports uniform /attire only.

9. Matches will be played on a knock-out basis.

10. Yonex Plastic Shuttle will be used to conduct tournament, which has to be purchased from the organisers

11. Food and accommodation will be provided to the out of station teams on prior request.

12. Confirmation of your participation and accommodation requests must be made on or before August 5th, 2022, to allow us time to make the necessary arrangements.

13. The decisions of the tournament committee shall be final in all matters pertaining to the tournament.

14. Team Managers will be held responsible for indiscipline of their students.
